Truman State University has selected benefits providers and plan benefits for the 2011 plan year, effective January 1, 2011 through December 31, 2011.

Anthem Blue Cross Blue Shield of Missouri, Delta Dental of Missouri, United Healthcare Vision, and CIGNA Life Insurance will continue to provide medical/prescription, dental, and life insurance benefits. A cafeteria plan will also be available through the Missouri Cafeteria Plan.

Anthem Blue Cross Blue Shield will continue to provide Plan A (low deductible), Plan B (high deductible) and the Health Savings Account (HSA) which will be referred to as the Lumenos Plan.

Delta Dental of Missouri will continue to provide Plan A (exam only) and Plan B (comprehensive).

United Healthcare Vision (formerly known as Spectera) will continue to provide Plan A (exam only) and Plan B (comprehensive).

MOCAFE will continue to provide Flexible Spending Accounts for out-of-pocket medical and dependent care expenses.

Times and locations of the presentations by the providers are enclosed. All providers will have representatives available in the Activities Room (3200).
